Equitocracy

Key definitions and terms used in this section

Aaahifa – Invariant spirituality. It can be experienced by all human being. It can be tested in a scientific manner, albeit in an extended science. *Ifa* in this word is inspired by spiritual practices in western Source-Eth (Africa). (See Definitions and Abbreviations for full definition.)

Aaahyalls – The spirituality that sincere people may engage in communal practices and experiments for both high level normal as well as supra-normal experiences that are felt by most of their community. (See Definitions and Abbreviations for full definition.)

Aaahyour – The deepest singular emotional expression. It is personal and individual. It is more fundamental than linguistics. (See Definitions and Abbreviations for full definition.)

abbr – abbreviation (Abbreviations here are still words, not always pronounced easily, of few letters use to designate the defined idea.)

acrm – (abbr) acronym (Acronyms here are still words, not always pronounced easily, formed by taking the first letter(s) in a series of words.)

BK – acrm of Bounty-Ken

Bounty-Ken – The people of the *sc* Western Hemisphere whose ancestors were there before 1491 CE. They are misnamed as Indians. Their ancestors first cultivated food stuffs such as maize (corn), tomatoes, potatoes, quinine, etc. They were the world's best mathematicians and astronomers in 1491 CE. The gold stolen from them by the Iberians is directly responsible for Europeans emerging from the "Dark Ages" and *sc* Western science

cka – acrm of commonly known as

Great Global Source-Ken Family – (acrm: GGSKF) all of the living people of the Eth approximately seven billion in 2011

Humrec – a concise name of human record in contrast to history Napoleon said that history is "fables agreed upon." *Sc* Western history is essentially about white supremacy. The *Humrec* is the total record of the 200,000 SE based GGSKF. Written words by forebearers are insufficient for what humans can know as truth

Invariant Ethics – GGSKF-made principles of human actions that apply equally to all subfamilies. These self-evident principles require humans to act in accordance with seeing themselves equal to one another, and as part of the wave of life existing on a fragile Eth such that the entire life spectra can continue for the natural life of each species (see the section *Invariant Ethics and Morality*).

MMSK – acrm of minimal melanin Source-Ken, *cka* European or person of European ancestry, or white person (This term reflects the fundamental Source-Ken lineage of *sc* the European subfamily.)

sc – acrm of so-called

SK – acrm of Source-Ken

SKUS – acrm of Source-Ken United States

Source-Eth – (acrm: SE) Africa; the source/creation place for all of the hominids over the last approximately six million years, and the creation place for *Homo sapiens* over the last approximately 200,000 years

Source-Ken – Africans; the mainfamily, the source/creation people; the parent people, and the original people of the GGSKF

Source-Ken United States – *cka* African-American

SUS – acrm of So-called United States. (Martin Luther King, Jr. likened the United States of America to the *New Testament* character, Nicodemus. MLK preached that after Jesus quickly sized-up Nicodemus, Jesus concluded that Nicodemus was too far gone and had to restart; that is, be born again. MLK's parable was that like Nicodemus, the United States of America was too far gone; it too had to re-constitute itself, that is, I independently came to the same conclusion. Throughout its history, the MMSKs who lived in the land now called the United States of America have murdered, stolen from, enslaved, and mistreated the Bounty-Ken and Source-Ken. Such actions were immoral, and the principles for such actions are unethical. Until the people of the United States of America have a new birth with respect to Bounty-Ken and to Source-Ken, I will refer to it in my writings as the So-called United States.)

WPHN – abbr of In the wake of Prince Henry the non-navigator, meaning starting around 1420 CE (This marks the onset of European attacks on Source-Ken.)

I have written about *Equitocracy* in other parts of this work. I bring them together here with an occasional slight modification.

From-Myth-to-Humrec

Much is made about the *sc* Greek creation of democracy. Roughly twenty percent of Grecians were *sc* citizens, the other roughly eighty percent were slaves. According to populations, this would be a slave state with an extended oligarchy. The duplicitous state of South Carolina, during Washington's presidency, was similar to this: roughly 60 percent enslaved SKUS and 20 percent non-voting MMSK females and at most 20 percent voting MMSK males. If this is democracy, the Great-Global Source-Ken Family (GGSKF) does not need that. Our essential genetic equality calls for a politico-economic-social, a newly coined term: *Equitocracy*. (An expanded definition is given at the end.) In this arrangement, all of the GGSKF has equal political rights and equal capital, after reparations are paid to Source-Ken (SK) and Bounty-Ken (BK).

From definition-part of God definition in Definitions and Abbreviations

The organizing idea of a belief system that enables a relatively small group of people to maintain some group integrity, promulgate some pseudo history, and practice some ethics-deadening rituals, such that the group can attack, or defeat, or control physically, or control psychologically, or control economically, or inflict genocide, or steal from, or enslave other groups of people. It occurs in Israelo-Judeo-Christian mythology. In Islam, it has the name Allah. This notion has nothing to do with the origins of the Summ (Universe(s)), *Invariant Ethics*, or *Equitocracy*.

When we look at the *Humrec* of its believers, this idea also has no consistent doctrine on justice, or peace, or freedom, or *Equitocracy*. Its believers may say that "God" told them to do it, and the believers become psychologically empowered to commit genocide or to prepare to use weapons of mass destruction such as nuclear weapons. Belief in God often suspends ethical beliefs and moral actions. There are some good aspects of God such as those practiced by Martin Luther King, Jr. One fact is that MLK chastised Christian Ministers in his letter from a Birmingham jail. Another fact is that the Civil War Confederate politicians and soldiers were more Christian than were the Civil War Union politicians and soldiers. If the rigors of verifiable truth in religion are at least as good as the rigors of verifiable truth in physics, then God fails. A literal analysis by one writer (Jack Miles) concludes that God is a warrior and the Bible is about victory. The GGSKF can no longer afford to delude itself with such a fanciful myth. A better approach is to re-create a world based upon *Equitocracy*, in which we live by *Invariant Ethics*, know that we are part of the *Wave of Life*, satisfy our spiritual needs with Aahifa and Aaahyour, or Aaahyalls, leave other fauna alone, do some get-your-hands-dirty-work, have fun, learn and create physics, make a little love, solve some math problems at your level of challenge, and listen to Aretha Franklin, Stevie Wonder, Ludwig Beethoven, John Coltrane, and if need be Johann Bach.

Have the practitioners of the God concept have done as much sustained damage to the GGSKF as have the practitioners of Hinduism with their trinity of Brahma, Vishnu, and Shiva? That question must be answered.

From SK Myth-The Source of Democracy True and False—Anti-Equitocracy

The SUS has been an “evil” state for many people since its inception. It is built upon three pillars: genocide of the BK Bottom people, enslavement of the SK people, and a flexible constitution the best part of which was derived from the philosophy of the Haudenosaunee (Iroquois) Confederation. The enslavement-consistent-constitution is the only half-way descent of these pillars. Yet, many elite MMSKs believe that the Constitution has been violated since Franklin Roosevelt’s presidency, as it has been interpreted far too liberally. The notions of freedom written about by John Locke and Jean Rousseau were inspired by feedback coming from Bounty Hemisphere; these ideas are not part of the Judeo-Christian Greco-Roman tradition. The latter tradition has privileges for a few nested in inferiority or slavery for the many. The implication here is that the philosophy of the Haudenosaunee Confederation stimulated the colonial revolution forming thereby the SUS. It also stimulated the 1789 CE French revolution and its aftermath which only ended in 1945 CE. We note that democracy in England did not start until the 1832 after the time that England was “outlawing” the slave trade in 1807. Certainly England did not provide the model for the SUS Constitution as significant rights for many English people did not happen until a series of Reform Acts in 1832, 1867, and 1884 and a Redistribution Act of 1885. Formerly enslaved SKUS men in the SUS obtained voting rights before most English males had that right. (Of course, MMSK created racist laws and practices eradicated that right for most SKUS males in the SUS South.) In England, voting rights were not given to all men over twenty-one and women over thirty until 1918, around the end of WWI. Women between twenty-one and thirty were granted voting rights ten years later in 1928. England was not the pattern for *sc* democracy in the SUS.

From SK Myth-More on the Special Role of SKUS

Our role is to bring *Equitocracy* to the Great Global Source-Ken Family (GGSKF). “Our” here means Source-Ken United States (African Americans) at the start, followed by Source-Ken World (all Africans) later, and all of the GGSKF can participate as equals. *Equitocracy*, in short, is the dynamic continually rebalancing state for the GGSKF in which each human has equal material wealth, each human has equal political wealth, and each human has equal access to education and health care while always respecting the rights of all sentient beings. Before *Equitocracy* is effectuated, there must be a “leveling of the playing field.” Reparations must be paid to the Source-Ken mainfamily and the Bounty-Ken subfamily that have been attacked by MMSKs WPHN. Reparations must also be paid by ABSKs to SK who attacked SK even longer than did MMSK. Reparations must also be paid to the Adivasis and to the Dalits of India, by the Varna subfamilies that have benefited from that ancient evil system. Reparations must also be paid to the people of Tibet and to the Uyghur (pronounced Weeger) by the Peoples Republic of China. Here the PRC must follow enlightened socialistic rules rather than greedy capitalistic rules. We will commence *Equitocracy* establishment by forming the GGSKF into a harmonious living/acting extended families.

MMSKs WPHN have over the last six hundred years, brought the world to the possibility of human extinction. Their apocalyptic beliefs system and their greed-based economic system have combined to annihilate many species and imperil the livability of the Eth for human and other high-level life forms. In their evil belief-system they have created the false concept of “race.” DNA analysis shows that there is no such thing as “races.” MMSKs have made human actions into a “race” for seeing who can steal/kill the most. We, all nearly seven billion in the GGSKF in mid-2011, are simply a collection of sub-families that came about through natural adaptations of the original colonizing Source-Ken to the various climes of the Eth (Earth) over the last 100,000 years.

We can and we must envision all humans as one extended family living in one house, the Eth. We can and we must structure our activities to be those of loving subfamilies who live in this one house forever.

From Definitions and Abbreviations

Equitocracy-A state that is based upon our equal genetic nature. Modern science has shown that human beings are about 99.85 percent genetically identical. In an *Equitocracy* each and every member of the GGSKF has sufficient resource for a decent life, equal political rights, and equal capital. An *Equitocracy* is the best politico-economic system as it mandates equal treatment of the entire human population. *Equitocracy* must come to be the condition of humans wherever they exist. *Equitocracy*, like equilibrium in simple physical systems, is dynamic, it continually rebalances. *Equitocracy* extends the one-man-one-vote idea to all people (women and men) having equal political, equal economic power, equal responsibility, and equal access to fun/ pleasure/ knowledge/ happiness. With *Equitocracy*, individuals and groups may strive for excellence. These individual and group goals must simply be directed to serve the GGSKF and all sentient beings in an ethical and Eth-sustaining manner.

From Resolving the God Program

We maintain the Eth such that it can support the spectra of life for as long as it can, limited by geological and meteorological conditions. Our economic system has traits like that developed in pre-Inca Peru where there was food for all, systematic natural cultivation of food products, and no money. If we choose to have money, then we will have one person-one vote, one person-money unit, and one person-one equal member of the Great-Global Source-Ken Family. I call this *Ethical Equitocracy*, or simply *Equitocracy*.

Taking Equitocracy

How will we take *Equitocracy* from where we are? We will do this by getting ourselves together as individuals. We will do this by getting organized into many nearly self-sufficient groups. We will do it by getting justice in the SUS (so-called United States), primarily using the non-violent tactics of people like the great Martin Luther King, but always achieving the objectives by any non-violent means as a modified Malcolm X, might say. We will do it by getting justice for Source-Ken (Africans) in Source-Eth (Africa). We will do it by getting justice for Source-Ken Global (Africans neither in the SUS nor Africa) in places where there are large numbers of Source-Ken Global (SKG) such as Brazil, Columbia, and Cuba. We will do it by getting justice wherever Source Ken (SK), Source-Ken Global (SKG), and Source-Ken United States (SKUS) live. The *Humrec* shows that the remainder of the Great-Global Source-Ken Family (all people) will be stimulated to follow us.
